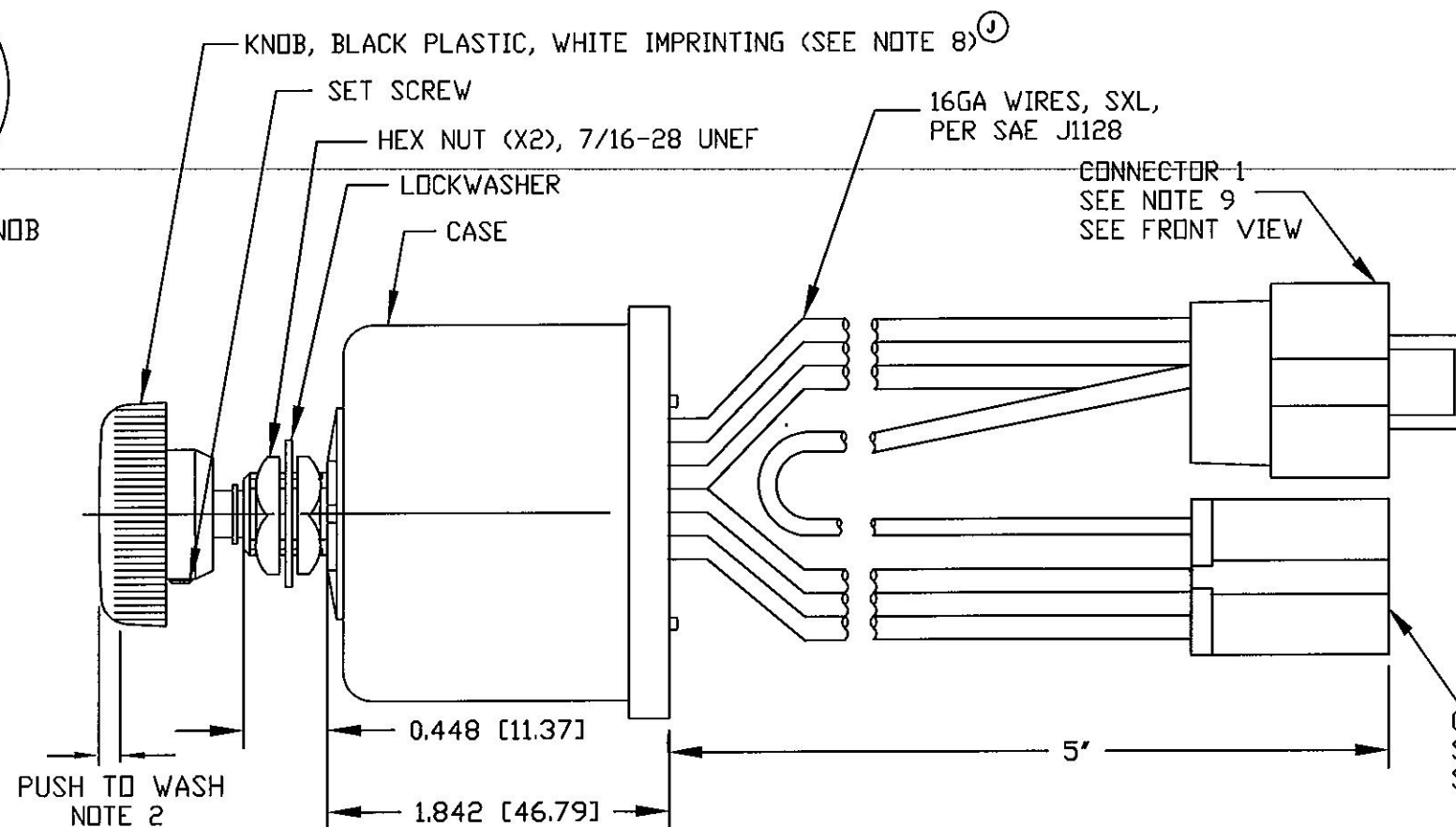
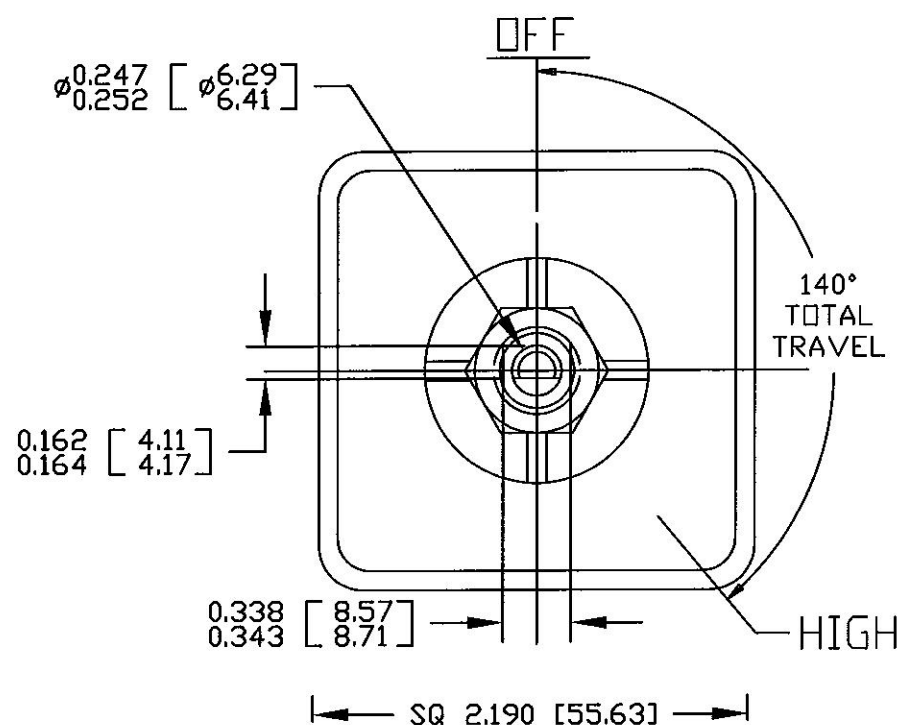
CONNECTOR VIEW FROM OPEN END
