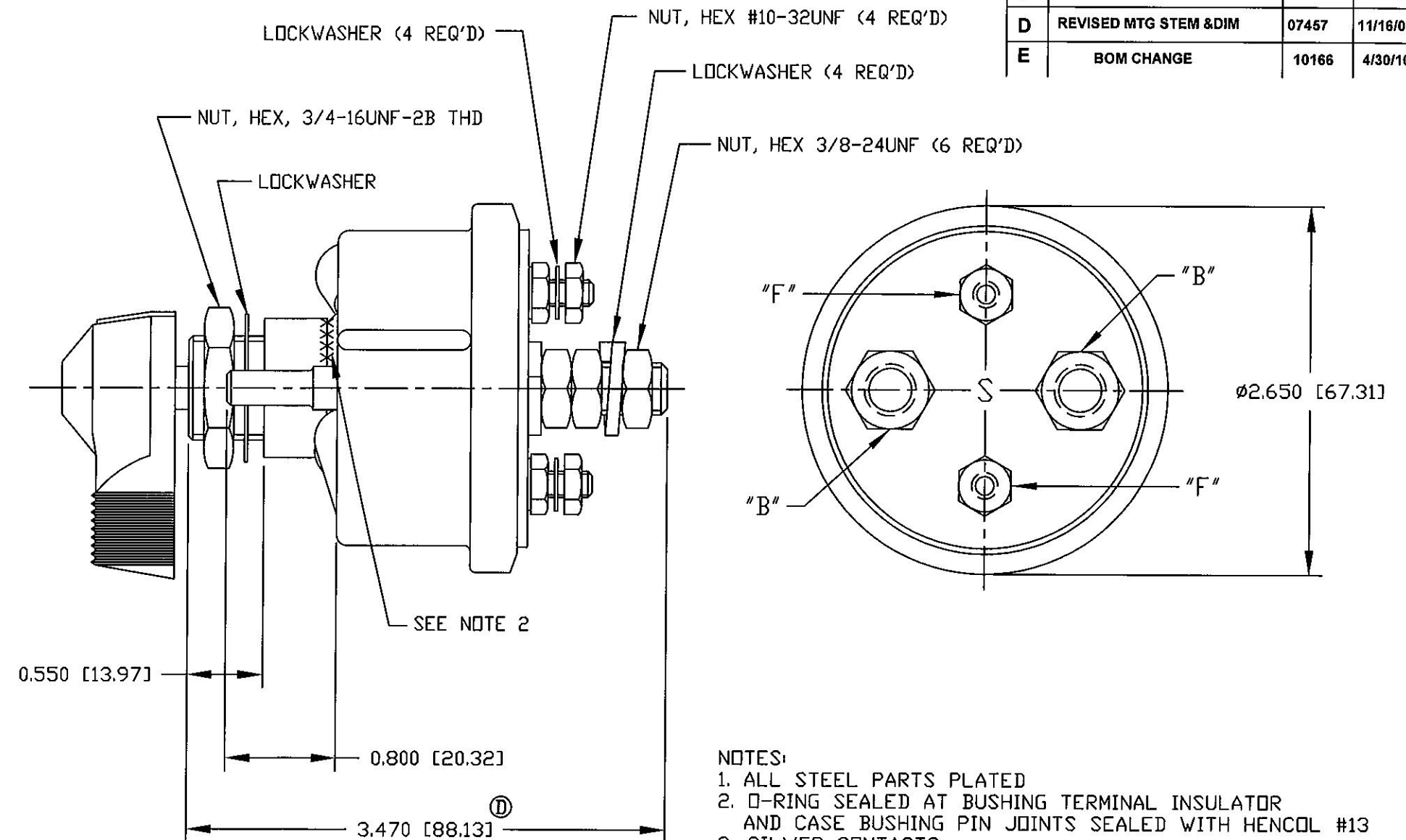
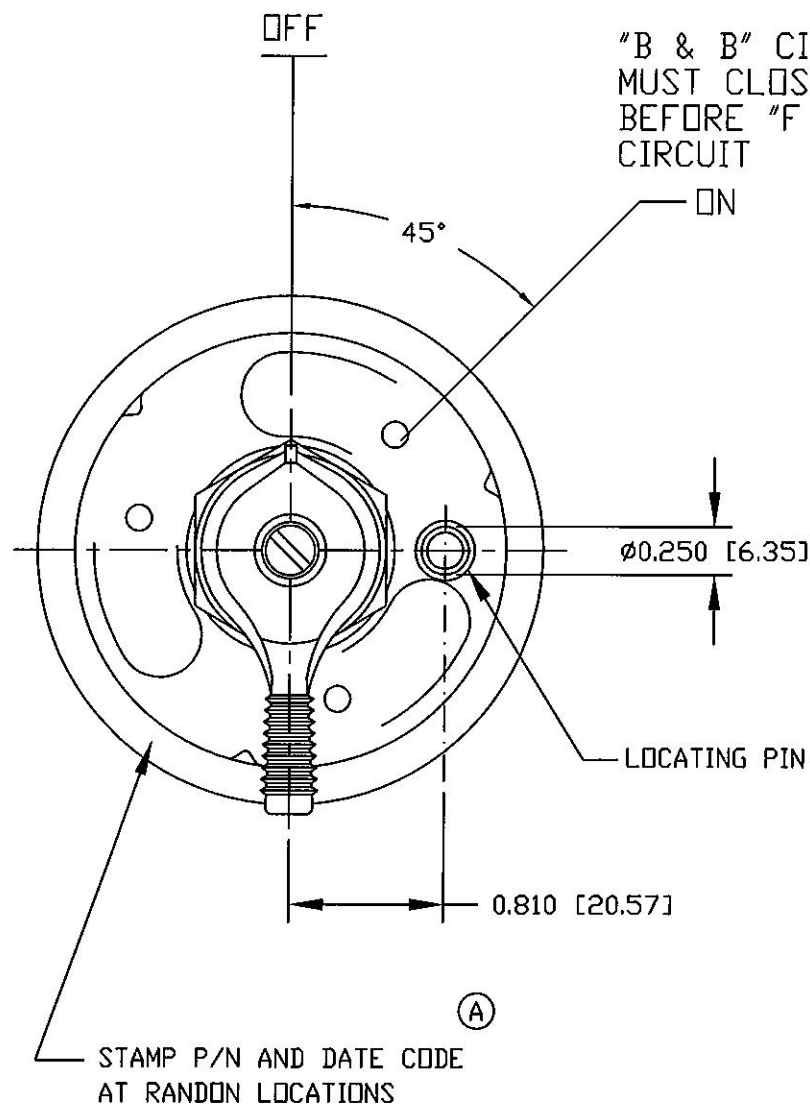


"F & F" CIRCUIT
